**Requests to translate and reprint CFR material** must also be made via the form on page 3. Please note that publication of a translation is contingent on written approval by the Council on Foreign Relations of the accuracy of the translation and its faithfulness to the original text in all respects, including but not limited to the author’s meaning, tone, and perspective. A fee will be charged to requestors for checking the translation text.

Permission is generally granted and a fee is assessed for articles and reports to which the Council on Foreign Relations holds the copyright. In cases where an author or other publisher holds the copyright, the most current contact information on file will be provided. Please expect a one- to two-week processing time for each request.

## **Please review the following policies and procedures for obtaining the necessary permission for content found on CFR.org.**

### *CFR PRESS CONTENT*

Any report found in the Books and Reports section of the Publications tab on CFR.org (Council Special Reports, Task Force reports, and Other Reports). Books are occasionally published under the CFR Press imprint; to confirm, please note the publisher listed on the book page. For most books found on CFR's website (which are published by university and trade presses, not by CFR Press), please see *NON-CFR CONTENT*.

Permission is required when reproducing, not simply quoting, a large amount (more than 250 words) of CFR Press material in course packets, in textbooks and trade books, and on websites.

**To request permission to reprint CFR Press content, please fill out the permission form on page 3.**

### *CFR.ORG ORIGINAL MATERIAL*

Most content found in the Background and Analysis section of the Publications tab on CFR.org, including Blogs. (Exceptions: Articles, *Foreign Affairs*, Op-Eds, and Testimony. See *NON-CFR CONTENT*.)

As with CFR Press content, permission is required when reproducing, not simply quoting, a large amount (more than 250 words) of CFR.org original material. Linking directly to an article on CFR.org is allowed, but permission must be requested to post a complete text or to post part of a text and link to the rest of the article on CFR.org. Reproductions must be of the complete, unedited text or section of text.

**To request permission to reproduce CFR.org original material, please fill out the permission form on page 3.**

### *AUDIO AND VIDEO*

Content may not be embedded directly on another site; rather, there must be a link to the content on CFR.org. Permission is required.
